1. Call to Order & Land Acknowledgement

The meeting was called to order at 5:31 p.m. by Skye Pomaineville, Chair of the Committee.

5. Presentations

a. Special Education Portfolio Information (Superintendent Pladzyk)

Superintendent Pladzyk said that he will be deferring this presentation to a different meeting, in the interest of keeping this meeting within a reasonable time.

b. Hearing Screening (Teacher Billie Doucette)

Teacher of the Deaf and Hard of Hearing, Billie Doucette, gave a presentation about our Board's hearing screening program. The goal of the project is to identify and eliminate barriers for our young learners which could be impacting their ability to be successful in a school setting. The board has formed partnerships with local service providers to provide free screening. The project began in spring of 2022, screening all kindergarten students, and has expanded in the years since. They have found that providing these screenings has opened up lines of communication for both parents and teachers to talk about and follow up on possible hearing difficulties. She explained the importance of identifying hearing loss, as it impacts brain development, and leads to many difficulties when left undiagnosed. She shared the results from the screenings since its inception, as well as stories of how this program has had a positive impact on various students across the board. The presentation slides are included [at the end](#).

Superintendent Pladzyk thanked her for the presentation and added that this screening is not a requirement for school boards. It is something that we, as a Board, have chosen to do at Billie's recommendation, which she brought to our Special Education depart. It is a way that we can support those essential primary reading and writing skills by removing barriers. It shows the passion and commitment that Billie has for her work, and the commitment we have as a Board to ensure all of our students have the tools they need to be successful.

Discussion followed:

- The screening takes place at the school. It is a brief screening, not a complete assessment. If they fail the screening, further testing is recommended.
- A barrier we are finding is the parents not being able to follow-up with full assessments at the hospital, due to financial, travel, or time constraints.
- When a student is recommended for further testing, the Special Education department will work with families on a one-to-one basis to assist if it is needed.
- The program is not funded by the Ministry, but we do get special education funds from them that we can apply for initiatives. We endeavor to help where we can.
- The waitlist like for the audiologist is not too long. Follow-up generally happens within a few weeks, not months and months.
- It is great to see teachers taking the initiative and reaching out to refer older students for screening when they see a possible issue. And to see how this results in such a positive impact in learning and behaviour.

Strategic Actions

- **Equity** – over the past three years DSB1 has been proactive at trying to identify/eliminate barriers for our young learners that could be impacting their ability to be successful in the school setting. Providing hearing screenings at our schools assisted with identifying students who may be struggling with their hearing. Not being able to hear properly impacts a child's brain development. It also has an impact on their social interactions with peers and adults.



- **Innovation** - for the past three years we have developed partnerships with Northern Ontario Audiology Services and Timiskaming Hearing Clinic to provide free hearing screenings to our kindergarten students. We also consulted with schools to identify older students who appear to be struggling with listening in the classroom setting. As a school board we realize that it is important for our students to have “clarity” in the classroom. Providing each elementary classroom with a Sound Field has assisted our students with obtaining “Clear Audible” information.



- **Culture** – Providing the hearing screenings in the school setting has opened up the lines of communication with school staff and families regarding the impact hearing loss has on a child's ability to learn. Schools are beginning to reach out to the board to see if a child has been screened or had full hearing assessments to assist with ruling out barriers that are impacting a student's ability to be successful in the classroom. Parents are following up with audiologists for further testing and being referred to ENTs/family doctors for medical attention.



Billie Richer
Teacher of the Hard of Hearing LSLS Cert. AVEd

- I have been employed with DSB1 since 2001 and I have been the Teacher of the Hard of Hearing for 21 years.
- In 2011 I became certified as a Listening and Spoken Language Specialist Cert. AVEd through A.G. Bell Academy for Listening and Spoken Language. Currently there are 1105 certified in the world, and 83 in Canada. This past month I finished up 17 hours of Continuing Education Credits to renew my certification.

- Leanne's practice is Timiskaming Hearing Clinic and has offices in Kirkland Lake and Temiskaming Shores.
- Our school board has worked with Leanne, and her staff for many years meeting the needs of our DSB1 Hard of Hearing students and students with Central Auditory Processing difficulties in the Southern region of our board.

- Marjo's practice is Northern Ontario Audiology Services and is in Timmins and Kapuskasing.
- Our school board has worked with Marjo, and her staff for many years meeting the needs of our DSB1 Hard of Hearing students and students with Central Auditory Processing difficulties in the Timmins and Northern regions of our board.



Why are Hearing Screenings Important?

- School-age hearing screenings are an important tool in identifying children with hearing loss who were not identified at birth, lost to follow-up, or who developed hearing loss later. Without routine hearing screenings, students with unilateral, less severe or late onset hearing loss may not be identified or will be misdiagnosed and managed.

Ears are the Doorway to the BRAIN! We Listen with the Brain!



Children with *Undiagnosed Hearing Loss* may have the following difficulties:

- hearing or understanding what's being said to them in a noisy room or from far away (sometimes called selective hearing)
- paying attention (they may be easily distracted)
- following spoken instructions and conversations
- acting out because they're frustrated
- keeping up with classroom work
- developing speech and language, including grammar and vocabulary
- missing small words (e.g., an, the)

Continued

- spelling, reading, and being able to recognize the different sounds in words (this is called phonemic awareness)
- hearing sounds clearly enough to be able to tell small differences in words (e.g., talked vs. talk vs. top, word endings including “-s”, “-ing”, “-ed”)
- getting along with other children and being confident in social settings
- becoming tired more easily than classmates
- missing important information when the conversation is not directed towards them
- being sensitive to loud sounds
- knowing where speech, warning sounds, environmental noises are coming from



The Process

- Spring of 2022 DSB1 approved the pilot project to screen all the 1st and 2nd year Kindergarten Students in the board.
- Spring of 2023 the school board screened 1st year Kindergarten Students (2018). Our 2016/2017 students who were absent in 2022 and new to the school board students were also screened. The audiologists also re-screened students who were referrals in 2022 that didn't follow up with further testing. The schools also referred older students that they had concerns about.



- Spring of 2024 the school board screened 1st year Kindergarten Students (2019). Our 2016/2017/2018 students who were absent in 2023 and new to the school board students were also screened. The audiologists also re-screened students who were referrals in 2023 that didn't follow up with further testing. Some of the schools also referred older students that they had concerns about.



- Our Teacher of the Hard of Hearing worked with schools to coordinate dates for screenings and sent home permission forms with a brief parent survey. There was also email follow up with parents and phone calls to get permission for students who didn't return forms.
- The audiologist and their teams went into all the schools in DSB1 to screen students.
- Results were sent home with students, and a copy of the screening was left at the school to be placed in the OSR.
- Audiologists followed up with parents for students who required further testing.
- Hearing Screening Data for each school has been compiled into charts and will be shared with schools for further follow up. We need to identify the barriers families are facing regarding following up with assessments.

Next Steps

- Follow up with schools regarding their data to see if they have had success getting a hold of families regarding referrals. To date we have screened 1744 students. The schools are currently following up with 399 families to see if they have followed up with audiologists and if there are any barriers for the families.
- The school board will continue hearing screenings in the spring of 2025 for new 2020 students.
- In the new year we will be discussing the students who have been screened multiple times and have had no follow up with the audiologist.

1. Call to Order & Land Acknowledgement

The meeting was called to order at 5:34 p.m. by Skye Pomainville, Chair of the Committee. She confirmed we do not have quorum, but will proceed with an informal meeting.

2. Welcome & Introductions

The meeting began with introductions, participants sharing their role or interest in PIC, as well as the school community they are a part of.

3. Approval of the Agenda

The agenda was shared and reviewed. No changes were requested.

4. Review of Minutes

No quorum. This item will be moved to the next meeting agenda.

5. Presentations

a. Special Education Portfolio Information (Superintendent Pladzyk)

Superintendent Pladzyk gave an overview of our Special Education portfolio, from foundational support, to prevention and interventions. Our philosophy is that even those requiring a high level of support and specialized programming should be given every opportunity possible to integrate into regular classrooms and school experiences.

He outlined the needs across the board and how they have changed over time, as well as how needs are met and how we assign staff supports. Most of our high support programs are at maximum capacity. He highlighted some stories of specific students, the challenges they face and how we have met them. He also shared some of the barriers the board is facing and how we are working to remove them.

The presentation slides are included at the end of these meeting notes.

Discussion followed:

- How many students are those 160 supporting? And how many are the JPEAs supporting?
 - Standard assignment in high support classrooms is 1 teacher with 2 EAs, with some variance depending on need.
 - JP funding applications are by student. They are 1 student to 1 EA in all cases.
- In Saskatoon they have had issues with JP funding not being provided for approved applications, and they've had to lay off some EAs. Does this happen here?
 - We are keeping close eye on this. We have seen some service providers who are having difficulties in getting their funding, but we are confident the Federal government will ensure the funding comes through.
- EAs support for our students is very important. The Board is continues to be highly committed to providing supports for our students, though it may look different with any changes around Jordan's Principle Funding.

6. Strategic Plan Vignette

The Strategic Plan Vignette for February (Science, Technology, Engineering, Arts and Math (STEAM)) was played. The link is available in the agenda, or you can visit the DSB1 [YouTube](#) channel to view this vignette and more.

7. Budget Discussions

a. PIC Annual Budget

Superintendent Pladzyk shared what our budget looks like, and what it has been used for in the past. He asked members to please consider these options as we look to decide on this years' spending.

No quorum. This item will be moved to the next meeting agenda.

b. Parent Education and Awareness Campaign

Superintendent Pladzyk shared that this campaign meshes well with current Mental Health Ontario and DSB1 mental health programming and supports. Our Mental Health Team has offered to plan this campaign, using their existing connections. As suggested in the campaign outline, this would include workshops and seminars, online webinars, collaborations with organizations, etc. Plans would be coordinated with local organizations, such as DSSAB, EarlyOn, Youth Wellness Hubs, Porcupine Health Unit, and other local services, such as police and counselling services. This would include things like workshops for parents to support their students, information sessions on such things as screentime, cannabis, vaping, digital technology, connections, and communication. There is also a plethora of information free online that can be shared.

They would plan for one session April, and one May. By March 6, Steve will send PIC the plan as a draft document for the committee to review and give feedback by email. If the plan doesn't use up all the funding, we would flow the remainder to schools for specific programming.

Everything would be promoted through social media platforms, to make it open for anyone interested to join online, with attendees able to ask questions through chat.

It was confirmed that, if some organizations have the capacity to do multiple sessions in different locations, in-person events, or even hybrid presentations, could be possible. There has been variable success with in-person events in the past. In-person events also tend to have higher costs, with travel, hotels, etc.

No quorum. This item will be moved to the next meeting agenda. Superintendent Pladzyk will provide a draft plan for the next meeting.

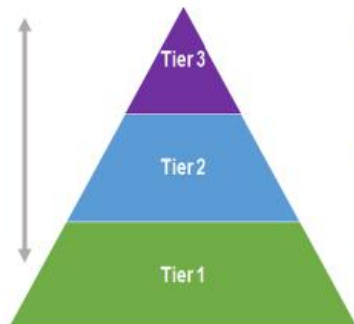

Targeted Prevention for some students

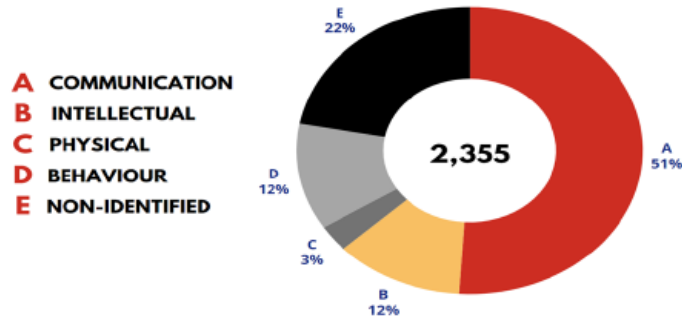
Specialized in-school assessment and interventions from support staff (SERT, EA, SSC, CYW, and/or SW).

Sound pedagogy, core classroom instruction, ongoing school-based assessments to monitor progress/identify early learning challenges and mental health concerns.

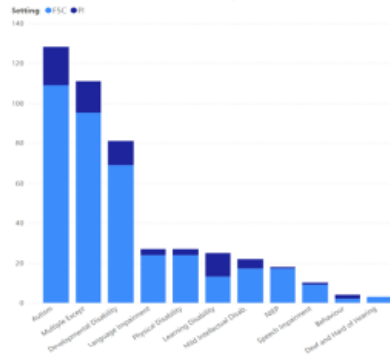


Students with Special Needs

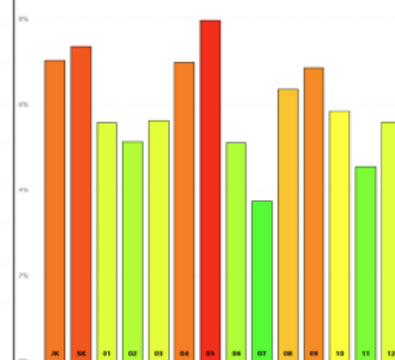


Students in High Support Classrooms

1. Call to Order & Land Acknowledgement

The meeting began with introductions, participants sharing their role or interest in PIC, as well as the school community they are a part of.

3. Approval of the Agenda

4. Review of Minutes

5. Presentations

a. Budget Consultation (Superintendent Pladzyk)

Superintendent Pladzyk shared an overview of the results from this years' annual budget survey. This survey gathers feedback from our school communities, stakeholders, and the public. Among the areas they feel we need to prioritize were Special Education (resources and personnel), Communications (social media, school platforms/programs), supports for students who identify as Indigenous (connections with Elders, communities, languages), and information services (new equipment/software, and upgrades). He noted that there were not a lot of survey responses, but what we did receive was very similar to previous years. All responses will be taken into consideration when preparing the budget.

b. PIC Funding Plan (Mental Health Lead Kazienko)

Board Mental Health Lead Elizabeth Kazienko shared the details of the plan she has put together for the Parent Education and Awareness Campaign funding. It will include a series of four webinars. The first two are being help in partnership with Northeastern Public Health, and the last two in partnership with Clarity Counselling.



All webinars will take place from noon to 1:00 p.m.:

1. The Truth About Cannabis: Thursday, April 17
2. Clear the Clouds: Thursday, May 1
3. Promoting Connection and Communication - Thursday, May 15
4. Helping Your Child Manage Digital Technology - Thursday, May 29

They will share information and supports, and provide tools on how to communicate and discuss these topics with children. As of today, the webinar about helping your child manage digital technology has the highest registration. It is very encouraging to see so much interest in this topic. Participants for each webinar will also have chance to win a prize basket with different games/activities for families to share together.

We are also partnering with Planet Youth Temiskaming and Drug Free Kids Canada to do in-person seminars for parents at TDSS, EHS, and KLDCS. These would provide in depth information and tips on how to support and to talk to kids. They will also include pizza and salad for folks to enjoy food while attending.

All of our initiatives are being advertised on our Board website and through social media. You can find links to our Facebook and Instagram on our website, in the top right corner. We are also asking our principals to send out details to their school communities.

Superintendent Pladzyk noted that Lead Kazienko has been able to be very frugal in organizing the spending for these. After arranging all of this, there was just over \$9,000 left. The suggested plan is to allocate all remaining funds equally between schools, to apply to any activities they have planned toward the end of the year.

Discussion:

- The funding received was based on these topics
- Idea is to share information with parents, who can then decide if, when and how to talk to their kids about any given topic
- The first two webinars are more relevant to grades 6 and up
- The second two are more applicable to all grades, even younger elementary

The meeting ended at 6:18 p.m.



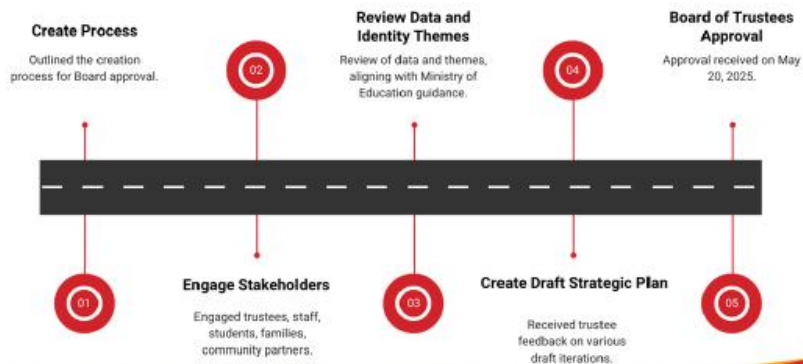
